Alabama Adopts New CCR Rule

On April 20, 2018, the Alabama Environmental Management Commission adopted new regulations governing coal combustion residuals (CCR), as proposed by ADEM. Most of the new regulations are found in a new Chapter 335-13-15 and took effect on June 8, 2018.

Alabama's regulations largely follow the structure and content of the federal CCR rule (40 C.F.R. Part 257, Subpart D). Like the federal rule, the state rule includes standards for CCR unit design, operation, and location. The new rules require groundwater monitoring and include new provisions for closure and post-closure care, as well as the posting of compliance-related information to the internet.

The rule includes a number of risk-based provisions, which have been referenced as "flexibilities," that are drawn directly from the municipal solid waste landfill (MSWLF) regulations of ADEM and EPA. Those provisions are subject to limitations that they do not take effect until 45 days after EPA approves them. In the 2015 preamble to the federal rule, EPA indicated it did not include these flexibilities because federal law did not authorize direct regulation by EPA and the states. In the absence of direct oversight, EPA was concerned about the possibility of noncompliance. However, in December 2016, Congress amended the Resource Conservation and Recovery Act to authorize states to submit CCR permitting programs for EPA approval. This rule represents the first step in that process for ADEM.

The new ADEM regulations include a few other items that differ from the federal rule. Boron is included on both Appendix III and Appendix IV, providing constituents for detection and assessment monitoring, respectively. Boron appears only on Appendix III of the federal rule, although EPA is considering a proposed rule to add it to Appendix IV as well. The state regulations establish a permitting program, and permit applications for existing facilities are due 180 days after the effective date (December 8, 2018). Permit applications are subject to typical procedures including public notice and an opportunity to request a public hearing. The regulations authorize ADEM to grant variances, as long as they are "in addition to or more stringent than" federal requirements.

The next step to gain federal approval is for ADEM to submit a package to EPA. EPA is required to act on the submission within 180 days of receiving a complete submission.
