2005 Annual Meeting & Technical Conference Summary

This year's conference began on Tuesday, August 9, 2005, with the golf outing at the Hermitage Golf Course. It was a great success and thoroughly enjoyed by all who were able to participate despite the sweltering heat. Attendance was down a bit due to some last minute cancellations. A tremendous thanks to Environmental Science, URS, Waller Lansden, Jack Daniels and SECOR who donated prizes for the event.

The annual technical conference was held in Nashville, Tennessee at the Sheraton Downtown. The event was successful and very well attended by a mixture of environmental professionals. Over 180 attendees witnessed technical presentations concerning the media of air, water, and land, which blended perfectly into the theme of "Continuing to Explore Innovative Solutions" to environmental problems. The price of admission included continental breakfast and break beverages on all three days, lunch on two days, the evening reception, and afternoon snacks and drinks on two days.

The conference began with the welcome ceremonies led by Shari Meghreblian, Western and Middle Tennessee Chapter Chair and Adrienne Carolla, Executive Director from International. After Adrienne's motivational speech of the benefits of being an A&WMA member, the keynote address by the United States Attorney for the Middle District of Tennessee, Jim Vines, was conveyed and was immediately followed by a panel discussion consisting of Tennessee Department of Environment and Conservation's Deputy Director, Paul Sloan, Jim Vines, U.S.E.P.A. Region 4's Director of the Air, Pesticides & Toxic Management Division, Beverly Banister, and Council to Assistant Administrator of U.S. E.P.A.'s Office of Air & Radiation in Washington D.C., Bill Wehrum. These panelists informed the audience how their respective areas are utilizing innovative ways to explore solutions. This session was well attended and considerable information was exchanged.

Concurrent technical sessions were held Wednesday afternoon where topical discussion was conducted relating to waste and air issues. Thursday, the concurrent technical session format continued which also

included issues related to water as well as wastewater. Over thirty-five presentations were given in the one and one-half days devoted to technical issues. The conference ended around noon on Friday after the regulatory update session. Regulatory representatives from states in the Southern Section gave an update on their respective states concerning both waste and air issues. The session ended with an update from E.P.A.'s Beverly Banister on the air side and Matt Robbins on the waste side.

Section business and timely keynotes filled the time devoted for lunch. Vince Adams, Chair, made a few announcements at the awards luncheon on Wednesday where Pleasant McNeel received his past chair's plaque. Student scholarship eligibility was given and the program moved into the keynote speaker. John Myers, Air Program Manager for TVA, addressed the audience and informed those listening about achievements TVA has made over the last few decades and how those trends are expected to last as they take a leadership role for the power industry. Thursday's luncheon brought Ray Tessier, General Motors Worldwide Facilities Group - Group Director for Environmental Services, to the head table and he delivered his message about the direction General Motors is going. He also relayed GM's support of recycling and their commitment concerning the environmental outlook on future generations of automobiles.

A presenter's breakfast and ready room was introduced in this years' conference, in which presenters could mingle with one another or use the time to polish their individual presentations. The breakfast was well received on all three days.

Exhibitors were present on Wednesday and Thursday. Discussion breaks led the attendees to the exhibition area where snacks and beverages were enjoyed. The exhibitors enjoyed the setup as it allowed them direct contact with attendees to promote their products and services.

After the conference was over on Friday, the customary

Board lunch meeting was held. A conference status was delivered and Phil Davis initiated plans for next year's conferences. It was announced the intended city is Point Clear, Alabama (Grand Hotel). Other general business was conducted which included an update about the Sections and Chapters Council discussion held in Minneapolis, Minnesota.

ADEM TO HOST 2005 CORRECTIVE ACTION STRATEGY MEETING

In September 2003, the United States Environmental Protection Agency (EPA) finalized its Strategic Plan for the years 2003 through 2008 as required by the Government Performance and Results Act (GPRA) of 1996. One of the goals outlined in EPA's strategic plan is the selection of final remedies (cleanup targets) at 30 percent of RCRA baseline facilities by 2008. In addition, the EPA published in 2002 a document entitled, *Beyond RCRA: Waste and Materials Management in the Year 2020* (a.k.a. the RCRA Vision Paper), which outlined possible directions for the mid- to long-term future of the RCRA program. In what has been termed the "2020 Vision," the EPA proposed in the vision paper that, "by the year 2020, cleanup of existing contamination problems at RCRA-regulated facilities will hopefully, largely be complete, though some long-term remediation work may still be ongoing, and some mechanism for addressing releases that may occur in the future will presumably be needed." The **Alabama Department of Environmental Management (ADEM)**, other State agencies, and industry representatives have worked with EPA for some time now to devise a strategy to achieve these goals.

To facilitate continued progress towards achieving sound and timely cleanups of contaminated sites within EPA's strategic goals, ADEM will host a one-day meeting on **November 2, 2005** at the Auburn Univer-

sity of Montgomery's **Taylor Center in Montgomery**, Alabama. The purpose of the meeting is to discuss these issues as well as the general state of the corrective action program in Alabama. A final agenda is under development for the meeting to include presentations from EPA, ADEM, and industry representatives on these and a variety of other topics. In addition, an open forum discussion of cleanup issues of general interest will be included.
