Call for Candidates - Board Elections

The following positions will be vacated this year:

VICE-CHAIR

(One year term ending January 2022, then assumes position of Chair for a one year term, and the position of Past Chair/Director for a one year term)

Assumes the duties and functions of the Chair in the event that the office of the Chair shall become vacant through resignation or other reasons; and presides at meetings in the absence of the Chair;

Appoints committees as requested by the Chair;

Plans quarterly dinner meetings.

SECRETARY

(Two year term ending January 2023)

Keeps a record of the minutes of all business meetings;

Conducts the correspondence of the Chapter, providing notices of meetings;

Maintains complete and accurate record of the membership roll.

TREASURER

(Two year term ending January 2023)

Receives and disburses funds in accordance with the policies determined by the Executive Board;

Furnishes financial reports for the business meetings of the Chapter or Executive Board meetings as required by the Chair;
