INSTRUCTIONS

I. DEADLINES

All completed applications, including documentation and transcripts, must be received by June 30th. An application will not be considered complete without all required supporting documentation. Scholarship recipients will be announced no later than July 31st.

II. ELIGIBILITY

Scholarship applicants must be enrolled full-time students currently attending, or graduating high school seniors registered to attend, a college or university located in Alabama. Applicants must also be pursuing a scientific degree with emphasis on an environmentally related field.

Incoming freshman must have a minimum ACT score of 18 or SAT score of 800 and should submit a copy of the letter of acceptance from their intended institution with their application.

Currently enrolled college students must be in any year of undergraduate study and must maintain a minimum GPA of 2.0. Students must also be enrolled full-time as defined by their college or university.

III. AWARDS

The Alabama Chapter of the A&WMA will be awarding up to two (2) \$1000 Environmental Scholarships.

IV. APPLICATION INSTRUCTIONS

Applicants must complete the form and submit the required documentation. Incomplete applications or applications without proper signatures will not be accepted.

The following supplemental documentation **must** be submitted with the application:

1. Official high school or college transcript w/ current GPA
2. 250-300 word essay (see application)
3. If a graduating high school senior, ACT/SAT scores and an acceptance letter from their chosen college or university

For graduating high school seniors, complete Appendices A and B.

For currently enrolled college students, complete Appendices A, B, C, and D.
