
The Need - Jackson Mississippi - Central Business District April 1979

Waste Issues

- One former creosote facility
 - Site includes "Creosote Slough"
 - Numerous prior EPA and MDEQ investigations
 - NFRAP determined last reviewed 2008



Waste Issues

- Two former "city dumps" pre-Solid Waste Disposal Act/RCRA
 - MDEQ conducted limited remediation due to erosion
 - Investigations conducted under Brownfield grants

LESSONS

- Keep the agency in the process regardless of their interest
- Can't provide too much information to agencies

The Public Comment Process

- Public Notice
- Public Meeting Format
- Time

- LESSON
 - - ignore the "noise" and stay with the legally required approach

Addressing NGO's - Lessons

- Offer early participation but don't expect them to accept
- Maintain careful communications at ALL times
- Expect biased public relations from NGO's
- Don't let their actions dictate your strategy
- Remember the goal of most NGO's
 - delay or stall the project


Dealing with the Press (and other sources of the "news")

- Formal press
 - Press releases and commenting
 - LESSON
 - Not every event or issue needs a comment or release
 - Keep responses simple
 - Develop a message and stick to it

LESSON

- Retain experienced PR firm with strong social media record (and the ability to understand scientific and engineering issues)
- Don't allow the social media posts to distract you from the goal

Addressing Agencies – Employee Duties

- Agency Policy v. Free Speech
 - Example 5: An employee of the Army Corps of Engineers is actively involved in the activities of an organization whose goals relate to protection of the environment. The employee may not, other than as permitted by agency procedures, give the organization or a newspaper reporter nonpublic information about long-range plans to build a particular dam. (5 CFR §2635.703)

- LESSON
 - Know the agency rules and be prepared to demand compliance
