A Chronological Summary of Recent New Source Review Regulatory Developments

(Editor's Note: *Thanks to Jim Little who wrote the editor in November 2003 volunteering to prepare this article. At the time, I think that he was hoping for a different emphasis, but you know the issue has been litigious from the beginning. We thank Jim for this chronological time line of developments. To say the least, the last year has been an interesting time for the new source review (NSR) regulatory program: two sets of final rule changes complete with legal challenges, the continuation of NSR enforcement cases, and even a U.S. Supreme Court case. The following is a chronology of some of the more important NSR events. - 12/31/02 - EPA promulgated final NSR rule revisions (67 FR 80186) with five actions: new definition of baseline actual emissions, new applicability test (past baseline actual emissions compared to projected actual emissions), new clean unit provision, new plantwide applicability limitation (PAL) provision, and revised provision for pollution control project exclusions. The rules became effective on 3/3/03 for reviewing authorities with "delegated" NSR permitting programs. Reviewing authorities with "SIP-approved" NSR permitting programs have until 1/2/06, to implement the rules. (All of the reviewing authorities in the eight southeastern states comprising EPA Region 4 have SIP-approved NSR programs with the exception of one limited part of the Florida program.) — Lawsuits were filed immediately with the U.S. Court of Appeals for the District of Columbia Circuit (DC Circuit Court) to overturn the final NSR rule revisions promulgated on 12/31/02. The lawsuits were consolidated by the DC Circuit Court into one case.
- 12/31/02 - EPA proposed NSR rule changes to better explain what is meant by the routine maintenance, repair, and replacement (RMRR) exemption. (RMRR changes are exempt from consideration as a physical change or change in the method of operation.)
- 2/05/03 - Petition to stay the final NSR rule revisions was made to the DC Circuit Court.
- 2/24/03 - The U.S. Supreme Court agreed to hear an appeal of a lower federal court decision from the Alaska Department of Environmental Conservation. The case (*Alaska Department of Environmental Conservation v. EPA et al.*) involves whether EPA acted properly in overruling the best available control technology (BACT) determination for a prevention of significant deterioration permitting action made by a state reviewing authority with its own SIP-approved NSR permitting program.
- 3/6/03 - DC Circuit Court denied the petition to stay the final rules promulgated on 12/31/02. Effective dates of rules remain as promulgated.
- 7/30/03 - EPA issued a notice of reconsideration (68 FR 44620) announcing that the agency would reconsider six specific parts of the 12/31/02 final rulemaking to assess whether changes were warranted.
- 11/7/03 - EPA issued a final decision on reconsideration (68 FR 63021) stating that the agency will not undertake any substantive revisions of the 12/31/02 final rulemaking. At the same time, EPA amended the NSR rules to include a definition of "replacement unit" and to clarify the PAL baseline calculation procedures for newly constructed units.
- 10/27/03 - EPA promulgated final NSR rule changes (68 FR 61248) related to the RMRR exemption. The revised rule, known as the equipment replacement provision (ERP) rule, more fully explains what is meant by routine replacement. EPA deferred rulemaking to explain routine maintenance and repair. The ERP rule includes a cost threshold for assessing whether a replacement should be considered routine. The rule was to become effective on 12/26/03 for reviewing authorities with delegated NSR programs. Reviewing authorities with SIP-approved NSR programs were to have until 10/26/06 to implement the ERP rule.
- 10/27/03 - Lawsuits were filed with the DC Circuit Court to overturn the ERP rule.
- 10/27/03 - Petition to stay the ERP rule was made to the DC Circuit Court.

- 12/24/03 - DC Circuit Court issued a stay of the ERP rule. The ERP rule is therefore on hold until the lawsuits to overturn the rule are decided. The NSR final rule revisions issued on 12/31/02 are not affected by the stay of the ERP rule.
- 1/21/04 - The U.S. Supreme Court issued its decision in *Alaska Department of Environmental*

Conservation v. EPA et al. (see above). In a 5-to-4 split decision, the majority held that "EPA has supervisory authority over the reasonableness of state permitting authorities' BACT determinations and may issue a stop construction order." The majority opinion hinged in part on an apparent lack of "evidentiary support" in the public record to justify the state's BACT determination.
