A: All have made the Shoals of Alabama their "home" at one time or another.

The Southern Section of the Air & Waste Management Association is pleased to announce that the 2006 Annual Meeting and Technical Conference will be held at the Marriott Shoals Hotel & Spa in Florence, Alabama, August 21 – 23. Located in the heart of the Southern Section in northwest corner of Alabama on the banks of the Tennessee River, the Shoals is less than a two hour drive from Birmingham, Nashville, Memphis and Tupelo, and less than four hours from Montgomery, Jackson, Atlanta and Chattanooga.

Located along the Robert Trent Jones Golf Trail, the Marriott Shoals Hotel & Spa has more than 200 guest rooms and suites, each with a private balcony and riverfront view, high-speed Internet access, separate shower and garden tub, large workspace, and refrigerator. The Marriott Shoals features three restaurants, including the rotating 360 atop the 22-story Renaissance Tower, a large, outdoor feature pool with water slide, a heated indoor pool and whirlpool, a fitness center and a 6000 square foot European-style spa and salon featuring professional massage therapists.

The Florence Convention Center, adjacent to the Marriott Shoals, will be the site of the Southern Section's technical presentations and exhibit hall. We anticipate approximately 200 environmental professionals and approximately 15 exhibitors at this year's conference.

A block of rooms is being held by the Marriott at the special conference rate of \$123 per night. A limited number of rooms are available at the government per diem rate of \$75 per night.
