

# 12 SHOOTING RANGES

ADCNR RANGES ARE LOCATED THROUGHOUT THE STATE. MOST RANGES HAVE MULTIPLE SHOOTING LANES AT VARIOUS YARDAGES FOR HANDGUN, RIFLE, AND SHOTGUN. RANGES ARE FUNDED THROUGH HUNTING AND FISHING LICENSE SALES.

## 23 PUBLIC FISHING LAKES

LOCATED IN **20 COUNTIES**THROUGHOUT THE STATE

**1,912 SURFACE ACRES** OF PUBLIC FISHING AREA ARE INTENSIVELY MANAGED TO PROVIDE QUALITY FISHING FOR ALABAMA CITIZENS.

ADDITIONAL RECREATIONAL OPPORTUNITIES SUCH AS HIKING TRAILS AND ARCHERY PARKS ARE BEING ADDED TO THESE AREAS.



## MORE THAN 150 BOAT RAMPS

ADCNR MAINTAINS MORE THAN 150 BOAT RAMPS AROUND THE STATE. THE RAMPS ALLOW ACCESS TO A WIDE VARIETY OF LAKES, RIVERS, STREAMS, AND COASTAL WATERS FOR FISHING AND BOATING.



3 FRESHWATER FISH HATCHERIES

THE HATCHERIES RAISE SEVERAL SPECIES OF FISH FOR STOCKING IN PUBLIC LAKES AND WATERS. THE HATCHERIES PRODUCE 3 MILLION FISH ANNUALLY.

# ARTIFICIAL REEF PROGRAM

ALABAMA HAS THE LARGEST ARTIFICIAL REEF
SYSTEM IN THE COUNTRY. VARIOUS STRUCTURES
ARE USED TO CREATE ARTIFICIAL REEFS, FROM
CONCRETE PYRAMIDS, MILITARY TANKS,
AND LARGE SHIPS TO OIL RIGS.

## FOREVER WILD LAND TRUST

FOREVER WILD LAND TRUST HAS SECURED MORE THAN 285,000 ACRES OF LAND ON MORE THAN 200 TRACTS IN 31 COUNTIES FOR PUBLIC USE, 99% OF WHICH ARE OPEN TO THE PUBLIC.

## TRACT ACQUISITION PROCESS

- Public nominates a tract
- Willing seller letter issued by staff to landowner for signature
- Tracts scored in each of the four qualifying categories to determine "short list" nominations
  - Must rank in top three of at least one program category
  - Tracts compete against other nominations in three geographic districts
- Board can only motion/vote for 1<sup>st</sup> appraisal from short list nominations
- Following 1<sup>st</sup> appraisal, board can motion/vote for 2<sup>nd</sup> appraisal and direct staff to proceed with acquisition process
  - <sup>2nd</sup> appraisal serves as confirming appraisal (must be within 10%)
    - If 2<sup>nd</sup> appraisal value not within 10% differential, obtain reconciliation appraisal
- Review due diligence items such as phase i/ii environmental site assessments and title commitment information
- Close tract acquisition and transfer amount equal to 15% of appraised value to stewardship account (established for long-term land management)



## FOREVER WILD LAND TRUST

FW CONSTITUTIONAL AMENDMENT APPROVED BY NEARLY 80% OF VOTERS IN 1992 AND 2012

**ACQUISITIONS HAVE CREATED:** 

- MORE THAN 350 MILES OF RECREATIONAL TRAILS WITHIN 22 RECREATION AREAS AND NATURE PRESERVES
- ADDITIONS TO 10 STATE PARKS
- ADDITIONS TO 16 WILDLIFE MANAGEMENT AREAS AND FOUR SOAs

15% OF APPRAISED VALUE OF EACH PURCHASE/TRANSFER GOES INTO STEWARDSHIP FUND FOR PERPETUAL MANAGEMENT AND TRACT IMPROVEMENTS



### What is CWD?

- CWD is one of a family of diseases known as Transmissible Spongiform Encephalopathies (TSE).
- Results from an infectious agent termed a prion. Prions are made of protein material that becomes misfolded in such a way that it becomes infectious, negatively affecting other proteins.
- Affects members of the Family Cervidae (deer), including reindeer, moose, elk, mule deer, white-tailed deer etc. Is contagious and always fatal.
- Infection can occur through animal-to-animal contact, through saliva, blood, semen, feces, infected carcass parts, and through environments contaminated by those infected materials.
- There is no known vaccine to prevent it or avenue to cure it at this time.

### Sources of Exposure

#### Two primary sources:


- 1. CWD-Infected Deer
  - Direct animal contact with an infected deer (alive or carcass) will likely be the initial source of contamination.

#### 2. CWD-Infected Environment

- As CWD becomes established in an area, the contaminated environment may become the primary route to exposure.
- No known methods of mitigating this risk once an area has been contaminated
